AN ORDINANCE CONFIRMING THE REINSTATEMENT OF A ONE  
HUNDRED PERCENT (100%) RECIPROCITY CREDIT OF THE TAX  
ASSESSED BY THIS ORDINANCE

*WHEREAS*, The Council of the Village of Lakemore has determined that it will be possible to reinstate the income tax credit once the Village of Lakemore has met all regulatory requirements outlined in Section 118 of the Ohio Revised Code;

Now, Therefore, Be It Ordained by the Council of the Village of Lakemore, Ohio:

Section 1: Upon the passage of the additional 4.25 mill Village of Lakemore Fire Department levy, the Village of Lakemore will apply for release from Fiscal Emergency designation.


Section 2: Upon release from Fiscal Emergency designation, Council will repeal Ordinance 1458-2011 and reinstate the one hundred percent (100%) reciprocity income tax credit.

Section 3: The Fiscal Officer will be directed to forward a copy of this Ordinance to the Regional Income Tax Agency immediately upon passage of the measure.

Section 4: All other Ordinances or Resolutions or parts of Ordinances or Resolutions inconsistent herewith are hereby repealed. All other Ordinances or Resolutions or parts of Ordinances or Resolutions not in conflict remain in full force and effect.

Section 5: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village of Lakemore, Ohio. Therefore, this Ordinance shall go into effect immediately.





PROCLAMATION

As representatives of the residents in the Village of Lakemore, Village of Lakemore Council is concerned for the health of the residents and supports Prostate Cancer Awareness month.

Whereas, prostate cancer is the most commonly diagnosed non-skin cancer in men and the second leading cause of cancer deaths in men; and

Whereas, everyday approximately 240,000 men are diagnosed with prostate cancer in the United States alone every year – one man every 2.63 minutes, roughly 30,000 die each year from the disease – one man every 17.52 minutes; and

Whereas, 1 in 7 men are diagnosed with prostate cancer. African American men are at the highest risk for the disease with a rate of 1 in 4 men. African American men are 2.5 times more likely to die from the disease; and

Whereas, education regarding prostate cancer and early detection strategies are critical to saving lives and preserving and protecting our families; and

Whereas, all men are at risk for prostate cancer. We encourage the citizens of the Village of Lakemore to increase the importance of prostate screenings.
