Be it Resolved by the Council of the Village of Lakemore, Ohio:




Section 2: That the Fiscal Officer is hereby authorized and directed to forward a copy of this resolution to the Summit County Fiscal Officer .

Section 3: This Resolution shall take effect on and after the earliest period allowed by law.




Be it Ordained by the Council of the Village of Lakemore, Ohio:

Section 1: The Council amends Article VI-Supplemental Regulations, Chapter 602 of Ordinance 1101-1989, regarding signs.


Section 2: The amended chapter is attached hereto and made part hereof, as if fully re-written within.

Section 3: That this ordinance shall be in effect from and after the earliest period allowed by law.


