Minutes for Council Meeting
June 22, 2015

Meeting Called to Order at 6:06 p.m.

Opening Roll Call: Ms. Snyder, Mrs. Cochran, Mrs. Coontz, Mr. Cole, Mr. Lance, and Mr. Timko present.

Pledge of Allegiance led by Mayor Justice

Reading of Ordinances and Resolutions

Resolution 6606-2015 "Hire Brett Reinbolt full-time for Fire department" 2ND read Coontz
Resolution 6611-2015 "Chief Saley salary reduction" 2ND read Coontz
Ordinance 1535-2015 "Amend Budget to Afford Payroll for Board of Zoning Appeals Members" 2ND read Lance

Old Business

Mrs. Coontz made a motion to suspend the third reading of Resolution 6606-2015. Motion was seconded by Mrs. Cochran. Roll call: Mrs. Cochran, Mrs. Coontz, Mr. Cole, Mr. Lance, Mr. Timko, and Ms. Snyder voted "yes". Motion carried.

Mrs. Coontz made a motion to adopt Resolution 6606-2015. Mr. Lance seconded the motion. Roll call: Mrs. Coontz, Mr. Cole, Mr. Lance, Mr. Timko, Ms. Snyder, and Mrs. Cochran voted "yes". Resolution adopted.

Mrs. Coontz made a motion to suspend the third reading of Resolution 6611-2015. Motion was seconded by Mr. Lance. Roll call: Mr. Cole, Mr. Lance, Mr. Timko, Ms. Snyder, and Mrs. Coontz voted "yes". Mrs. Cochran voted "no". Motion carried.

Mrs. Cochran stated did not agree with reducing Chief Saley's salary, as he is a dedicated employee who works more hours than he is paid.

Mr. Cole stated he believes employees should not feel they should accept a salary reduction to further the progress of the Village.

Mr. Lance stated he was supporting the legislation, as Chief Saley requested this reduction. Mayor Justice stated Chief Saley had the utmost confidence in Brett Reinbolt to handle the daily responsibilities, which would allow the Chief to work fewer hours.

Mrs. Coontz made a motion to adopt Resolution 6611-2015. Mr. Lance seconded the motion. Roll call: Mr. Lance and Mr. Timko voted "yes". Ms. Snyder, Mrs. Cochran, Mrs. Coontz, and Mr. Cole voted "no". Resolution failed.

Mr. Lance made a motion to suspend the third reading of Ordinance 1535-2015. Mr. Timko seconded the motion. Roll call: Mr. Timko, Ms. Snyder, Mrs. Cochran, Mrs. Coontz, Mr. Cole, and Mr. Lance voted "yes". Motion carried.

Mr. Lance makes a motion to adopt Ordinance 1535-2015. Mr. Timko seconded the motion. Roll call: Ms. Snyder, Mrs. Cochran, Mrs. Coontz, Mr. Cole, Mr. Lance, and Mr. Timko voted "yes". Ordinance adopted.

Mr. Cole made a motion to Dispense with the Regular Order of Business to permit residents to Appear Before Council. Motion was seconded by Mr. Lance. Roll call: Mrs. Cochran, Mrs. Coontz, Mr. Cole, Mr. Lance, Mr. Timko, and Ms. Snyder voted "yes". Motion carried.

Randy and Gail Gonzales of 1495 First Street reported their property is being flooded from neighbors' downspouts and the flooding occurring in the area. Mayor Justice ensured them the Department of Public Services was working to install an additional pipe. The Village and Springfield Township are working cooperatively to maintain a reduced lake level. The Department of Public Services had reconnected a pipe to Front Street to reduce the flooding potential. Mayor Justice confirmed he and Gene Taylor would evaluate their situation on Tuesday, June 23, 2015.

Mr. Cole made a motion to Return to the Regular Order of Business. Mr. Lance seconded the motion. Roll call: Mrs. Coontz, Mr. Cole, Mr. Lance, Mr. Timko, Ms. Snyder, and Mrs. Cochran voted "yes". Motion carried.

Motion for Adjournment was made by Mr. Lance and seconded by Mr. Timko. Roll call: Mr. Cole, Mr. Lance, Mr. Timko, Ms. Snyder, Mrs. Cochran, and Mrs. Coontz voted "yes". Meeting adjourned at 6:29 p.m.
