WHEREAS, Council desires to create a Motor Vehicle Impoundment Policy and fees associated with the procedure,

Now, Therefore, Be It Ordained by the Council of the Village of Lakemore, Ohio:

Section 1: Council adopts the Village of Lakemore Police Department Motor Vehicle Impoundment Policy Number P-401.07.


Section 2: Council establishes the Administrative fee for impounding vehicles and Police Department Storage fee in this policy.

Section 3: A copy of Police Number P-401.07 is attached hereto and made part of as if fully re-written herein.

Section 4: All Ordinances or Resolutions or parts of Ordinances or Resolutions inconsistent herewith are hereby repealed. All Ordinances and Resolutions which are not inconsistent herewith are hereby confirmed.


Section 5: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village of Lakemore, Ohio, for the reason that the Lakemore Police Department requires specific policies in place for enforcement and collection of fees. Therefore, this Ordinance shall go into effect immediately.

A RESOLUTION AUTHORIZING THE MAYOR AND FIRE CHIEF TO APPLY FOR 2017 FUNDING FROM OHIO BUREAU OF WORKERS' COMPENSATION. TO AFFORD FIRE SAFETY GEAR

Be it Resolved by the Council of the Village of Lakemore, Ohio:

- Section 1: That the Mayor and Fire Chief are hereby authorized to apply for 2017 funding from the Ohio Bureau of Workers' Compensation to afford cancer barrier hoods and firefighter gloves.
