AN ORDINANCE AMENDING ORDINANCE NO 1532-2015  
BY ADJUSTING THE SEWER BASE RATES FOR RESIDENT AND  
COMMERCIAL USERS.

WHEREAS, the Village of Lakemore and the community foresee a need to change the base rate for sanitary sewer services in order to meet operating expenses, debt obligations and capital reserve needs; and

WHEREAS, sufficient funds are necessary to maintain this fund.

Now, Therefore, Be It Ordained by the Council of the Village of Lakemore, Ohio:

Section 1: That Ordinance No. 1532-2015 is hereby amended as follows:

The Residential and Commercial Base Sewer Rate will be increased by \$2.00 per month to total \$91.00 per quarter for each residential and commercial unit.

Section 2: This rate will be effective on the October 1, 2017, bill.

Section 3: That, except as amended herein, the existing provisions of Ordinance 1532-2015 together with all previous amendments thereto, shall remain in full force and effect.

Section 4: This Ordinance shall be in effect from and after the earliest period allowed by law.
